Therefore, applicants are only required to submit a letter expressing their interest by indicating the specific projects that they are interested for.

Expressions of Interest letter must be delivered to the address below on or before **August 31, 2017 at 4:30 p.m.** Late submissions may be rejected.

The expression of Interest result will be announced through ERA website.

- ✓ Bidders which would like to participate in association shall indicate the form of association specifically as sub-consultancy or joint venture.
- ✓ Performance record of firms will be assessed and considered for the short listing on the projects.
- ✓ Firms required to have Grade I Category Relevant Professional Practice Certificates renewed for at least 2009EC from authorized bodies except for Construction Management Consultants which is Grade II Category Relevant Professional Practice Certificates renewed for at least 2009EC.
